We wish to advise that on October 30, 2006, Sklar-Peppler Furniture Corporation ("SPFC") obtained an Order from the *Ontario* Superior Court of Justice effectively terminating the proceedings previously commenced under the *Companies' Creditors Arrangement Act* and, upon its filing of a Notice of Intention to Make a Proposal ("NOI"), continuing the proceedings under Section 50 of the *Bankruptcy and Insolvency Act* ("BIA"). Accordingly, on October 30, 2006, SPFC filed a NOI, a copy of which is enclosed herewith.

SPFC is not bankrupt, but has availed itself of a procedure whereby an insolvent person, with creditor and Court approval, restructures its financial affairs. Our role as Trustee in this matter is to assist with the development of the Proposal, to liaise with creditors to explain same to them and to aid in the decision that creditors will ultimately make regarding the Proposal. We also monitor the cash flow of SPFC during this process.

All liabilities of SPFC as at October 30, 2006 are frozen by force of the BIA and will be subject to the Proposal mentioned above. Please note that during this process, SPFC is not bankrupt but is continuing to proceed under protection from the legislation.

Sklar-Peppler Furniture Corporation has thirty (30) days from the date of filing the Notice of Intention to Make a Proposal to lodge a Proposal with ourselves, subject to Court extension. Once this Proposal is filed with the Official Receiver, the Trustee is required to call a Meeting of Creditors within twenty-one (21) days thereafter.
