**CONSENT ORDER STAYING MOTION TO REJECT COLLECTIVE  
BARGAINING AGREEMENT PURSUANT TO SECTION 1113**

With the consent of the Parties (as defined below), this order addresses the Motion of Allied Systems, Ltd., Transport Support, LLC and F.J. Boutell Driveway, LLC (collectively, the "Allied Movants") to Reject Collective Bargaining Agreement Pursuant to Section 1113 filed on February 2, 2007 (the "Motion"). The hearing on the Motion is scheduled to commence on February 20, 2007.

It appears that this Court has jurisdiction over this proceeding; that this is a core proceeding; and that the Allied Movants and the United States Teamsters<sup>1</sup> (each a "Party" and, collectively, the "Parties") consent and agree to stay litigation of the Motion under the terms and conditions set forth below. It further appears that no Party has waived any of its respective rights as part of this consent order except as may be expressly stated herein. Accordingly, it is hereby ORDERED as follows:

1. All litigation concerning the Motion is suspended and stayed until further order of this Court upon request by either Party.

2. The hearing on the Motion is removed from the Court's February 20, 2007 hearing calendar.

3. The time within which the Court must schedule a hearing on the Motion, as set forth in 11 U.S.C. § 1113(d)(1) is hereby suspended. The filing hereafter by any Party of an application for hearing on the Motion shall be treated like the filing of an application for rejection for the purpose of establishing, pursuant to 11 U.S.C. § 1113(d)(1), the time within which the Court shall schedule a hearing. Thus, the time within which the Court must rule on the Motion, as provided in 11 U.S.C. § 1113(d)(2), will be computed from the commencement of any hearing hereafter scheduled.

4. All discovery in connection with the Motion is hereby stayed until the filing of an application for hearing on the Motion by any Party.

5. The subpoenas issued by the United States Teamsters for the production of documents at the hearing presently set for February 20, 2007 shall be deemed to have been issued in connection with any hearing rescheduled pursuant to this order.


6. This order is without prejudice to the right of any Party to file an application for hearing at any time.

7. The Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this order.

8. Counsel for the Allied Movants is directed to cause a copy of this Order to be served upon all parties on the Master Service List (as such term is defined in the Order Establishing Notice Procedures entered on August 2, 2005 in these jointly administered cases)

and the United States Teamsters by U.S. mail within three (3) days of entry of this Order and to file a certificate of service with the Clerk of the Court.
